#### Notice of Termination

I understand Gymnastics Gold requires a written one (1) month termination of participation notice. This will be submitted to the front office. If notice is not received, I understand that I will be billed for one (1) month's tuition.

#### Absences

In our effort to keep tuition reasonable, any student that is absent from a class must bring in a doctor's excuse in order to make up the class. Students without a note will not be allowed to make up the missed class. (Make ups for illness /family emergencies ONLY)

Please read carefully, sign, and return with your \$25 registration fee.

1. **FEES:** Registration fees are nonrefundable. Registration is \$25 for all members. CLASS FEES ARE DUE THE FIRST CLASS OF THE MONTH, past due after the close of business hours on the 10th of the month, and subject to a \$10 LATE CHARGE. If tuition is outstanding by the 10th of the next month, the student will be dropped from the class. Dropped students will only be accepted when all past dues fees and late charges are paid and IF THERE IS AVAILABILITY IN THE CLASS. NO STUDENTS WILL BE PLACED IN A CLASS WITHOUT PAYMENT! NO EXCEPTIONS!

2. **TUITION:** Prices for classes are based on a 9-month period. Due to this, tuition price is the same for every month regardless of 3-week or 5-week months.

3. **METHOD OF PAYMENT:** Gymnastics Gold accepts all forms of payment including, cash, checks and credit cards. Please make all checks payable to Gymnastics Gold. Please write your child's name on all checks. A \$15 fee is assessed for all returned checks and must be paid in cash. Auto draft from your checking account or credit card is available. Please ask the front desk for the appropriate forms to get started. Receipts will be given upon request. Payments can now be paid online through our website. You must have a valid e-mail on file to be able to access this option.

4. **WITHDRAWAL OF CLASS:** A 30 day handwritten/typed notice must be submitted to the front desk. If no notice is received, you are still responsible for those 30 days regardless of your child's attendance in the class.

5. **GYMNASTICS ATTIRE:** Leotards are preferred, but not necessary. Other apparel suitable is a one-piece bathing suit, elastic shorts and a comfortable shirt. Long hair must be pulled back away from the face, preferably in a ponytail. Please do not use fancy hairpieces. NO shoes or socks are worn in class. NO TIGHTS ARE TO BE WORN. Leotards are available in our pro-shop ranging in price from \$20-\$36 along with hair scrunchies (\$3-\$4).

6. **TUMBLING ATTIRE:** Elastic shorts (i.e. gym shorts), t-shirts, and tennis shoes are required for tumbling and cheer tech classes. Shirts must be tight fitting or tucked in. SPORTS BRAS OR TWO PIECE OUTFITS ARE NOT ALLOWED.

7. **ATTENDANCE:** Our classes advance each week. It is important your child attends regularly in order to keep up with the class. NO TUITION DEDUCTIONS FOR MISSED CLASSES. Check our online calendar for scheduled closings. In case of inclement weather, call the gym. Classes cancelled due to severe weather will NOT be rescheduled.

Gymnastics Gold reserves the right to cancel, combine, or reschedule classes as enrollment requires. Gymnastics Gold reserves the right to refuse service to any student at any time with just cause or reason.

I have read and fully understand this contract and will abide by it for the current season. I also understand that if any part of this contract is violated, my child is subject to dismissal without refund of any money.
